Privacy Policy

Introduction

This privacy notice sets out the way we process your information and how we use it. We will always refer to this policy when we ask you for your consent. The Data Controller is the Committee of U3A Bermagui & District Inc.

How we collect your information

We collect your personal information when you complete a membership enrolment or renewal form or you register to receive our newsletter.

Data we gather

We ask you to provide your name, address, telephone number, mobile number and email.

How we use it

1) Administration of Your Membership

For example, to record your subscription payment, to notify you that your membership is about to expire, to enrol you in a U3A course, to give you notice of our Annual General Meeting and to inform you of U3A activities

2) Managing your Application to join a Course

We will pass your information to the course leader so that they can inform you of additional information on the course you have enrolled in.

Sharing your data with other organisations

We do not share your data with other organisations other than as set out below:

Join It online membership system

Join It provides our on-line membership system. We have assessed their security measures and are satisfied that they are a suitable organisation to share your data with.

Mailchimp electronic newsletter management system

When you register with us for a newsletter, your information is stored in Mailchimp to allow us to distribute an e-newsletter to you. We have assessed their security measures and are satisfied that they are a suitable organisation to share your data with.

How long is your information kept

We retain your information for one year after your membership lapses in case you decide to re-join in this period.

Your rights

You have the right to ask us, in writing, for a copy of all the personal data held about you (this is known as a "subject access request"). You should write to:

If you do this, you should include your telephone number so we can verify your identity.

You can also ask us to delete all the information we hold about you. You can make this request in writing to the membership officer at the above address.

The NSW State Government requires that we provide access to inspect current member information if requested by a member. You can request this access by writing to the address above. Please note that all requests for access to member lists will be advised to the committee.

Updating and amending your personal information and consent preferences

If your information needs amending or you wish to modify your consent to the way your information is used, you can change it yourself by logging in to our membership website https://www.joinit.org/o/u3a-bermagui using your email address and the password set when you first joined U3A Bermagui & District Inc. What is a Cookie?

A cookie is a small file placed on your computer's hard drive. It enables our website to identify your computer as you view different pages on our website.

How we use Cookies

We use them to recognise you when you return to our website or our Membership system.
